#### REMARKS ORDERED PRINTED

On motion of Senator Lucio and by unanimous consent, his remarks regarding **SB 1968** were ordered reduced to writing and printed in the *Senate Journal* as follows:

SB 1968, A Fundamental Attack on Public Employees' Freedom of Association. SB 1968 by Huffman would unjustifiably ban the voluntary choice by state and local employees (other than police, firefighters and emergency services personnel) to direct a portion of paychecks to labor, employee or professional organizations of their choice. The bill would harm teachers, engineers, child protection workers, correctional officers, custodians, clerks and a host of other state and local employees who are engaged in public service and seek to improve their livelihoods through organization membership.

This is about allowing state employees to spend their paychecks as they see fit, not about endorsing or opposing any particular set of ideas or organizations. The state should not pick winners and losers when it comes to payroll deduction. The state allows hundreds of organizations to receive voluntary deductions from state employee paychecks.

Every state and local employee in Texas who chooses to steer a portion of paychecks to pay for representation by a labor, employee or professional organization has done so voluntarily. A payroll deduction system is a commonplace service in both public and private workplaces in Texas.

Payroll deduction provides a safe and secure means of making payments in timely fashion. The payroll deduction system removes virtually all risk of ID theft and credit card fraud.

No state or local funds are used to operate the payroll deduction system. State law provides for payment of administrative costs by the organizations receiving the proceeds of payroll deductions.

Without justification, SB 1968 strips local governments that accommodate employee choices for payroll deductions of the right to do so.

SB 1968 improperly establishes a hierarchy of public employees in which some are deemed worthy of payroll deduction while others are not. All job categories are entitled to respect and the distinction made in this bill is not justifiable based on characteristics of the work performed.

The payroll deduction system has served public employees well for decades by protecting their ability to choose and to allocate their resources safely. SB 1968 would compromise the freedom of association that undergirds the payroll deduction system.
