REMARKS ORDERED PRINTED

On motion of Senator Garcia and by unanimous consent, her remarks regarding Manuel "Manny" Rodriguez were ordered reduced to writing and printed in the *Senate Journal* as follows:

Members, I rise today to pay tribute to Houston Independent School District Trustee Manuel "Manny" Rodriguez. Trustee Rodriguez passed away in Houston on Wednesday, July 19th, at the age of 65. Trustee Rodriguez was a pillar in the HISD community, a champion for public education and his constituents in District III for over a decade. Before serving HISD, Trustee Rodriguez was a product of HISD, graduating from Austin High School in Houston's East End in 1970. A lifelong public servant, he served in the U.S. Air Force, worked as a community-relations specialist in the City of Houston, and was the founder of the MARVAA Corporation, which provides assistance in education, housing, and community involvement. Trustee Rodriguez was elected to the HISD board in 2003, and over the years held every office on the board, including President. During his tenure, he successfully fought for dual credit programs in Houston high schools and was integral in creating the maritime programs at Austin and Yates high schools. From 2008-2011, Trustee Rodriguez represented HISD on the Board of Directors of the Texas Association of School Boards, and in 2010, he was elected President of the Mexican American School Board Members Association. Members, I personally knew Manny for many years, and while we didn't see eye to eye on every issue, I never once doubted his commitment to public education and the children of Houston. He was a fighter, and he never forgot where he came from or who he represented. Every child in HISD is better off because of his service. I would like to offer condolences to his family, especially his wife of over 44 years, Virginia Rodriguez.
