# COMMITTEE SUBSTITUTE SENATE BILL 1083 ON SECOND READING

CSSB 1083, Relating to the applicability of the sales and use tax to certain insurance services.

## Floor Amendment No. 1

Amend **CSSB 1083** (senate committee printing) by striking SECTION 1 of the bill, amending Section 151.0039(b), Tax Code (page 1, lines 30-44), and substituting the following:

SECTION 1. Section 151.0039, Tax Code, is amended by amending Subsection (b) and adding Subsection (c) to read as follows:

- (b) "Insurance service" does not include:
- (1) insurance coverage for which a premium is paid or commissions paid to insurance agents for the sale of insurance or annuities; [or]
- (2) a service performed on behalf of an insured by a person licensed under Chapter 4102, Insurance Code;
- (3) a service performed by a certified public accountancy firm, if less than one percent of the firm's total revenue in the prior calendar year is from services in this state that would otherwise constitute insurance service under Subsection (a); or
- (4) a service performed on behalf of a certified public accountancy firm by an owner of the firm or a member of the firm's affiliated group, if less than one percent of the owner's or member's total revenue in the prior calendar year is from services in this state that would otherwise constitute insurance service under Subsection (a).
  - (c) In this section:
    - (1) "Affiliated group" has the meaning assigned by Section 171.0001.
- (2) "Certified public accountancy firm" has the meaning assigned by Section 901.002, Occupations Code.

SECTION 1. Subchapter D, Chapter 35, Utilities Code, is amended by adding Section 35.107 to read as follows:

Sec. 35.107. EXPIRATION OF AUTHORITY TO SELL OR CONVEY POWER. (a) Notwithstanding another provision of this subchapter, the commissioner's authority to sell or convey power under this subchapter expires September 1, 2022.

(b) This section does not affect the commissioner's authority to sell or convey natural gas under this subchapter.

- SECTION 2. (a) The General Land Office or an entity operating under a contract with the General Land Office may continue to provide retail electric service in accordance with Subchapter D, Chapter 35, Utilities Code, as that subchapter existed before the effective date of this Act, under the terms of an agreement with a customer entered into before the effective date of this Act, only until the date the agreement expires.
- (b) The General Land Office may not renew or extend the expiration or termination date of a contract to provide retail electric service in accordance with Subchapter D, Chapter 35, Utilities Code, to a date after September 1, 2022.

SECTION 3. This Act takes effect September 1, 2017.

(a) A person commits an offense if the person knowingly gives, permits, or obtains unauthorized access to information submitted to the board under Section 481.074(q), [ext] 481.075, or 481.0751.

SECTION \_\_\_\_\_. Section 554.051(a-1), Occupations Code, is amended to read as follows:

(a-1) The board may adopt rules to administer Sections 481.073, 481.074, 481.075, 481.0751, 481.076, [and] 481.0761, 481.0762, 481.0763, 481.0764, and 481.0765, Health and Safety Code.

- (7) In SECTION 4 of the bill, strike amended Sections 481.076(i) and (j), Health and Safety Code (page 4, lines 4-20).
- (8) In the recital to SECTION 5 of the bill (page 4, line 22), strike "amending Subsections (a) and (c) and".
- (9) In SECTION 5 of the bill, strike amended Sections 481.0761(a) and (c), Health and Safety Code (page 4, lines 24-50).
- (10) In SECTION 5 of the bill, in added Section 481.0761(i), Health and Safety Code (page 4, line 62), strike "481.074(q), 481.075, and 481.0751" and substitute "481.074(q) and 481.075".
- (11) In SECTION 6 of the bill, in added Section 481.0762(b), Health and Safety Code (page 5, line 26), strike "481.074(q), 481.075, and 481.0751" and substitute "481.074(q) and 481.075".
- (12) In SECTION 6 of the bill, strike added Section 481.0762(c), Health and Safety Code (page 5, lines 29-33).
- (13) In SECTION 6 of the bill, in added Section 481.0762(d), Health and Safety Code (page 5, lines 34-35), strike "or dispensing veterinarian".
- (14) In SECTION 6 of the bill, strike added Section 481.0762(e), Health and Safety Code (page 5, lines 38-47), and substitute the following:
- (e) In determining whether a potentially harmful prescribing pattern or practice is occurring, the appropriate regulatory agency, at a minimum, shall consider:
- (1) the number of times a prescriber prescribes opioids, benzodiazepines, barbiturates, or carisoprodol; and
- (2) for prescriptions described by Subdivision (1), patterns of prescribing combinations of those drugs and other dangerous combinations of drugs identified by the board.

- (15) In SECTION 6 of the bill, in added Section 481.0762(f), Health and Safety Code (page 5, line 50), between "prescribing" and "patterns", strike "or dispensing".
- (16) In SECTION 6 of the bill, reletter the remaining subsections of added Section 481.0762, Health and Safety Code (page 5, lines 17-55), appropriately, and correct cross-references to those subsections accordingly.
