## **REMARKS ORDERED PRINTED**

On motion of Senator Kolkhorst and by unanimous consent, Senator Birdwell's remarks regarding **SR 549** were ordered reduced to writing and printed in the *Senate Journal*.

On motion of Senator Menéndez and by unanimous consent, all remarks regarding **SR 549** were ordered reduced to writing and printed in the *Senate Journal* as follows:

Senator Fallon: Thank you, Mr. President and Members. Members, if I could have your attention, this is a very unique moment. Approximately 42 million Americans have worn the uniform over the course of our nation's history. We have some veterans here in the Chamber with us, and today we're honored with two Medal of Honor recipients. Of the patriots that have served, 3,500 members of the 42 million have received this honor, and only 1,059 since 1900. We have two American heroes and American treasures with us today. They would not call themselves heroes, but they are. Of the 22 million living veterans just 71 have been awarded the Medal of Honor, and we're fortunate, as I said, to have Sergeant Gary Michael Rose with us. Sergeant Rose was awarded the Medal of Honor on October 23, 2017, by President Trump for his actions in Laos in September 1970, while serving as a medic with the 5th Special Forces, 1st Special Forces Division. For many years this mission, Operation Tailwind, was classified. Deep inside enemy territory, Sergeant Rose braved a hail of bullets, mortar rounds, and enemy B-40 rockets, sprinting 50 meters to a wounded soldier's side. Suddenly, a rocket impacted just meters from him injuring his head, hand, and foot. Ignoring his wounds, he attempted to hoist wounded personnel onto a hovering helicopter. Over the next two days, Sergeant Rose continued to help care for the wounded, estimated to be half of the entire company. After the Marine door gunner on the final helicopter was shot in the neck, Sergeant Rose also gave him aid and he saved his life. Unfortunately, that helicopter crashed several hundred meters from the evacuation point. Surviving the crash, Rose pulled and carried unconscious and wounded comrades from the burning wreckage until a helicopter arrived. He recovered and returned home to live a remarkable life. For his incredible bravery and service in defense of our nation, the House and Senate have passed this concurrent resolution. And second, I want to welcome Sergeant Gary Beikirch. Sergeant Beikirch was awarded the Medal of Honor on October 15, 1973, by President Richard Nixon for his actions defending Camp Dak Seang during the Vietnam War, while serving as a medical airman of Detachment B-24, Company B. The allied defenders suffered a number of casualties during an intense, devastating attack on the camp. At the beginning of the assault, Sergeant Beikirch manned a 4.2-inch mortar. When it was destroyed by an enemy mortar round, he took over the machine gun. Seeing a fellow Green Beret go down, he ran through heavy fire to help him, and in doing so he was hit by mortar shrapnel in the spine and was paralyzed. Despite this he got two South Vietnamese comrades to carry him through enemy fire so he could treat the fallen, villagers and soldiers alike. As he applied mouth-to-mouth resuscitation to another soldier, Sergeant Beikirch was again shot, this time in the side and stomach. Bleeding heavily and barely conscious, he continued to fire on the enemy while being dragged away by the triage men for treatment. Remarkably he, too, survived this incident,

recovering over six months at Valley Forge Medical Center, slowly relearning to walk. For his remarkable bravery in service and defense of our nation, the House and Senate have passed this Concurrent Resolution 100. Joining Sergeant Beikirch today is his wife, Loreen. Please join me in welcoming them to their state, or our, this Texas State Capitol, in this Chamber.

President: We have a few other Members before we welcome them.

Senator Fallon: Absolutely.

**President:** Have a few other Members who would like to speak. Lieutenant Colonel Birdwell, Senator Birdwell.

Senator Birdwell: Thank you, Mr. President, Members. Thank you, gentlemen, for joining us. The nature of your service, it is a, I mean, I've had the privilege of meeting Medal of Honor winners, and there's actually a large book, Members, of, that provides the citations of Medal of Honor recipients. And in the Pentagon, there's a, there's a small little area that, that's called the Hall of Heroes, and it's got the name of every Medal of Honor winner. And at my time at, at the Pentagon, when, when there were times I would take folks through that, that were visiting, I'd always take them there. These men are very special. I want you to understand just how special they are. There's a Korean War citation for Captain Millett, and most of us think of, particularly with the first Gulf War and since being a very high tech video game, and it's not. During the Napoleonic wars, of which the Civil War was the last of the Napoleonic wars, bayonet charges were routine, but the last American bayonet charge was led by Captain Millett in 1952 on the Korean peninsula. While I don't have the citations of Sergeant Rose and Sergeant Beikirch, that's the category of courage that we are speaking of here. For every man that has earned the Medal of Honor, there's 10 men that were with him earning it. So, I want to make sure, Members, that we're not just simply recognizing two men that are wearing the most distinguished medal, that we're recognizing every man and woman that was with these two men, earning it with them. Because when I got to meet Captain Millett, back in 2000, the 14 men that charged that Chinese position, out of ammunition with bayonets fixed, only four survived. But those 13 other men were who had earned that Medal of Honor with Captain Millett. And that's what these gentlemen represent now, and I want you to know one other thing, the President of the United States is the Commander in the Chief, and in every circumstance but one receives the salute, except for surviving members or surviving individuals that did not receive their Congressional Medal of Honor posthumously. The President of the United States initiates the salute to a man wearing the Congressional Medal of Honor. I want you to understand exactly the nature of valor and honor that is standing in this Chamber today. Thank you, gentlemen, particularly in the wars that you were in. You came home not to shower away the smell of battle or the sting of jungle, but you came to wash away the contempt of your fellow Americans after the Vietnam War was over with. Let this nation never again make such a mistake. God bless you. Thank you to each one of you. Hooah. Thank you for this resolution, Senator Fallon.

President: Thank you, Senator Birdwell. Senator Nelson.

**Senator Nelson:** Thank you, Mr. President, and thank you, Senator Fallon, for bringing this resolution before us. I have an opportunity to visit Gainesville on a very regular basis and, Members, if you have never had the opportunity to be up there, they have a three-day weekend that they honor Congressional medal heroes from all over the country. They raise money to fly them into DFW airport. There is a caravan accompanied by our blue from all over North Texas that escort them up 35 from DFW airport to Gainesville, and every overpass has flags hanging down, people up there waving, saluting our heroes, and they spend three, and I think there were about 35 maybe last time, Senator Fallon, up there. They go into our schools, talk to our children, it is the neatest thing you could ever imagine, honoring these heroes. And Rand McNally recognized Gainesville a few years back as the most patriotic city in the country, because of what they do for our heroes. So, thank you, Senator Fallon, for bringing this to our attention. And, certainly, thank you to our Congressional Medal of Honor heroes. We appreciate you.

President: Thank you, Senator Nelson. Senator Kolkhorst.

Senator Kolkhorst: Thank you, Mr. President. I rise to, of course, honor those heroes that stand on our Senate floor today. I would like, Mr. President, to have the words that were given by Lieutenant Colonel Birdwell, Senator Birdwell, reduced to writing and put in the Journal that forever, generations to come, can read what he said.

**President:** Thank you, Senator Kolkhorst. Any objection to that motion? Hearing none, the motion is adopted. Senator Campbell, you're recognized.

**Senator Campbell:** Thank you, Mr. President and Members. Thank you, Senator Fallon, for bringing our Congressional Medal of Honor men with us today. As Chairwoman of Veterans Affairs and Border Security, I always start the meeting with there's no more honorable profession and no greater title of valor that anyone can have than to be called a veteran. Thank you for what you've done. Thank you for your mindset in the life that you've led, preserving and protecting our freedom. We all live under the banner of the work that you did to defend our country. Thank you for that, very much, from the bottom of our hearts. Thank you, Mr. President.

(2) In SECTION 4 of the bill, immediately following amended Section 161.082(e), Health and Safety Code, (page 1, between lines 59 and 60), insert the following new subsection:

(f) It is an exception to prosecution under Subsection (a)(1) that the person to whom the cigarette, e-cigarette, or tobacco product was sold:

(1) is at least 18 years of age;

(2) is on active duty in the United States military forces or the state military forces; and

(3) presented at the time of purchase a valid military identification card.

(3) In SECTION 7 of the bill, in amended Section 161.084(b), Health and Safety Code (page 2, line 31), immediately following "WEIGHT.", insert the following:

THE PROHIBITIONS DESCRIBED ABOVE DO NOT APPLY TO A PERSON WHO IS ON ACTIVE DUTY IN THE UNITED STATES MILITARY FORCES OR STATE MILITARY FORCES.

(4) In SECTION 13 of the bill, immediately following amended Section 161.252(c), Health and Safety Code (page 4, between lines 34 and 35), insert the following new subsection:

(c-1) It is an exception to the application of this section that the individual younger than 21 years of age:

(1) is at least 18 years of age;

(2) is on active duty in the United States military forces or the state military forces; and

 $\overline{(3)}$  presents at the time of purchase a valid military identification card.

The amendment to CSSB 21 was read and was adopted by a viva voce vote.
