# COMMITTEE SUBSTITUTE SENATE BILL 8 ON SECOND READING

On motion of Senator Nelson and by unanimous consent, the regular order of business and Senate Rule 7.12(a) were suspended to take up for consideration **CSSB** 8 at this time on its second reading:

**CSSB 8**, Relating to making appropriations of certain federal coronavirus relief money.

The bill was read second time.

## (Senator Perry in Chair)

Senator Menéndez offered the following amendment to the bill:

## Floor Amendment No. 1

Amend **CSSB 8** (senate committee printing) as follows:

- (1) In SECTION 7 of the bill, in the appropriations for compensation for the Department of Public Safety (page 3, line 6), strike "\$806,836,021" and substitute "\$796.836,021".
- (2) Add the following appropriately numbered SECTION to the bill and renumber subsequent SECTIONS of the bill accordingly:

SECTION \_\_\_\_. DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES: INTEGRATED AND INTEROPERABLE DATA SYSTEM. (a) The amount of \$10,000,000 is appropriated to the Department of Family and Protective Services from money received by this state from the Coronavirus State Fiscal Recovery Fund (42 U.S.C. Section 802) established under the American Rescue Plan Act of 2021 (Pub. L. No. 117-2) and deposited to the credit of the Coronavirus Relief Fund No. 325 for the purpose of providing funding for maintenance and upgrades to the department data system during the state fiscal biennium beginning September 1, 2021.

- (b) The department shall prioritize the expenditure of money appropriated under subsection (a) of this section to further the goal of making the data system integrated and interoperable, in collaboration with retained external experts, stakeholders, and legislative committees with appropriate jurisdiction.
- (c) The department shall submit to the Legislative Budget Board a plan for improvements to the data system for which money is appropriated by Subsection (a) of this section before disbursement of the money, except for money for the retention of external experts and related administrative costs.

The amendment to **CSSB 8** was read.

- (2) Add the following appropriately numbered SECTION to the bill and renumber subsequent SECTIONS of the bill accordingly:

SECTION \_\_\_\_\_. DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES: KINSHIP CAREGIVERS. (a) The amount of \$20,000,000 is appropriated to the Department of Family and Protective Services from money received by this state from the Coronavirus State Fiscal Recovery Fund (42 U.S.C. Section 802) established under the American Rescue Plan Act of 2021 (Pub. L. No. 117-2) and deposited to the credit of the Coronavirus Relief Fund No. 325 for the purpose of providing funding for a kinship caregiver pool during the state fiscal biennium beginning September 1, 2021.

(b) In allocating the money appropriated by Subsection (a) of this section, the department shall prioritize kinship caregivers serving high needs children requiring specialized services, and kinship caregivers who could be trained to provide treatment foster care level services for children in the caregiver's care and other children.

The amendment to **CSSB 8** was read.

- (2) Add the following appropriately numbered SECTION to the bill and renumber subsequent SECTIONS of the bill accordingly:

SECTION \_\_\_\_. DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES: BONUS PAY FOR FRONT LINE CHILD-SERVING STAFF. The amount of \$96,100,000 is appropriated to the Department of Family and Protective Services from money received by this state from the Coronavirus State Fiscal Recovery Fund (42 U.S.C. Section 802) established under the American Rescue Plan Act of 2021 (Pub. L. No. 117-2) and deposited to the credit of the Coronavirus Relief Fund No. 325 for the state fiscal biennium beginning September 1, 2021, for the purpose of providing funding for bonus pay for front line child-serving staff in the child welfare system as authorized by other law.

The amendment to **CSSB 8** was read.

- (2) Add the following appropriately numbered SECTION to the bill and renumber subsequent SECTIONS of the bill accordingly:

SECTION \_\_\_\_. DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES: PURCHASED CLIENT SERVICES. The amount of \$35,100,000 is appropriated to the Department of Family and Protective Services from money received by this state from the Coronavirus State Fiscal Recovery Fund (42 U.S.C. Section 802) established under the American Rescue Plan Act of 2021 (Pub. L. No. 117-2) and deposited to the credit of the Coronavirus Relief Fund No. 325 for the state fiscal biennium beginning September 1, 2021, for the purpose of providing funding for purchased client services, to be allocated as follows:

- (1) \$5,900,000 for adopted purchased services;
- (2) \$11,600,000 for substance abuse purchased services; and
- (3) \$17,600,000 for other purchased child protective services.

The amendment to **CSSB 8** was read.

Senator Menéndez withdrew Floor Amendment No. 4.

Senator Johnson offered the following amendment to the bill:

## Floor Amendment No. 5

Amend **CSSB 8** by adding the following appropriately numbered section:

SECTION\_. REPORT ON FEDERAL FUNDS BY THE LEGISLATIVE BUDGET BOARD. (a) The Legislative Budget Board, in consultation with the Comptroller of Public Accounts, shall provide, in a publicly available database on the Legislative Budget Board's website:

- (1) an informational listing of all federal funding received pursuant to the coronavirus disease public health emergency by any political subdivision of the state of Texas. The data shall be disaggregated by political subdivision to the greatest extent possible.
- (2) a detailed informational listing of all federal funding received pursuant to the coronavirus disease public health emergency by any state agency or institution of higher education of the state of Texas. The data shall be disaggregated by individual agency or institution to the greatest extent possible and contain:
- (a) the amount of funding received by each state agency or institution of higher education;

- (b) the federal legislation, and state legislation, if applicable, that appropriated the funding;
- (c) whether the funding was received directly from an appropriation from the federal government, or passed through another state agency;
- (d) the amount of funding expended by the state agency or institution of higher education to date;
- (e) the purpose(s) for which the state agency or institution of higher education has expended funds;
- (f) all allowable uses of the funds for which the state agency or institution of higher education may expend the funds;
- (g) the amount of funds remaining unspent over which the state agency or institution of higher education retains appropriation authority;
- (h) the time frame during which the funds were expended by the state agency or institution of higher education, including any remaining time with which the state agency or institution of higher education may expend the funds if funds remain:
- (i) the amount of and plans for any additional funding expected to be received in the next fiscal year; and
- (j) any additional information requested by a member of the Senate Finance Committee or House Committee on Appropriations.
- (b) The data shall be updated at least quarterly beginning on December 1, 2021 and updated on the first day of each fiscal quarter thereafter.

The amendment to **CSSB 8** was read.

Senator Johnson withdrew Floor Amendment No. 5.

**CSSB 8** was passed to engrossment by a viva voce vote.

All Members are deemed to have voted "Yea" on the passage to engrossment.

## COMMITTEE SUBSTITUTE SENATE BILL 8 ON THIRD READING

Senator Nelson moved that Senate Rule 7.18 and the Constitutional Rule requiring bills to be read on three several days be suspended and that CSSB 8 be placed on its third reading and final passage.
